

LaShars Performing Team Registration, Liability, and Attendance Policy 2023-24

*Tuition: will be due the first week of the month unless other arrangements are made. We can take a payment by phone, in the studio store, or on our new online portal through Dance Studio Pro. An \$8.00 late fee will be added for each month the account goes overdue.

*Regular attendance is required to hold a place in class and to be included in performances. Performing team students must attend two competitions and be available for team performances and practices throughout the year. Tuition is standard each month. Make up classes are not available.

*Attire: Dancers will be required to wear appropriate dance clothes to class, including the correct dance shoes. No denim or school clothes. No street shoes. Classes will wear tap shoes and tan jazz shoes, with suntan tights.

*Performing Team dancers will need to be responsible for showing up with their hair and make-up ready and bringing every piece of their costume to performances, as well as arriving on time. Each team member must be committed to attending class and events with the team, learning the routines, and working hard to improve flexibility, turns, and technique.

*Registration Fee: There will be a non-refundable registration fee at the beginning of each year which will be used to cover class hand-outs, treats, props, and parties throughout the year.

*Costumes: All performing team classes will have a Jazz costume, a Hip hop costume that includes shoes, and will select their own dress for lyrical (details to follow). A costume deposit will be due in October to place an order on your Jazz costume. The deposit will go towards the total cost of the Jazz costume which will be \$68.00. Our advanced Lyrical Class as well as the Advanced Musical Theatre class, will also get a separate costume.

*Performances may include: Festival of Trees, Basketball and Football Halftime performances, Invitationals, Local Events, Competitions, and the final Recital.
